PDS and the IAM are committed to protecting your privacy. We comply with the principles of the Data Protection Act 1998 and aim to maintain consistently high levels of best practice in our processing of personal data.

### **How we use information you provide us**

The Atlas Online Booking System is provided by Professional Driver Service Limited (PDS) and has been designed to allow users to book and pay online for a driver retraining course. Driver retraining courses will be supplied to you by the service provider who operates in your preferred region. We use the information we receive from you to help your local service provider deliver the services that you have requested, to assist them with communicating with you, and to personalise the information sent to you. We store all the information you provide us, including information provided via forms you complete on this website. Our server, in common with nearly all web servers, logs each page that is downloaded from the site. Third parties may deliver some of our products to you or provide all or part of the service requested by you. In these instances, whilst the information you provide will be disclosed to them, it will only be used for the administration of the service provided and to maintain management information for business analysis. We may ask for your home address and postcode, home telephone number, mobile telephone number, and email address to enable us to contact you in relation to the course booking you have made, to contact you if there is a problem with your order, or if there is another genuine reason for doing so. If you provide us with credit or debit card details in order to pay for a service, we will keep such details secure and ensure that the details are only used further with your consent and/or for the purposes of any appropriate refunds. Generally by providing the requested data you consent to the Service Provider using that data for administrative purposes. As required by the Data Protection Act 1998, we follow strict security procedures in the storage and disclosure of information you have given to us.

### **How we use cookies**

"Cookies" are small pieces of information sent by a web server to a web browser, which enables the server to collect information from the browser. PDS uses cookies for a number of purposes, for instance to enable us to simplify the logging on process for registered users, to help ensure the security and authenticity of
